Eligibility Criteria: : AS PER GOVERNMENT NOTIFICATION DATED 24-12-2025 (NEW EDUCATION POLICY 2020)

1. **Nursery** : The Age of the child should be 3 + years on or before 30 September 2024.
2. **LKG** : The Age of the child should be 4 + years on or before 30 September 2023.
3. **UKG** : The Age of the child should be 5 + years on or before 30 September 2022.

- ❖ Birth Certificate in original is to be submitted without fail.
- ❖ If previous school has generated the PEN Number of the ward then please submit the same at the time of admission.
