Eligibility Criteria:

1. Nursery : The Date of Birth of the child should be between 01 March 2020 to 28 Feb 2021 (inclusive of both dates) (3 + years)

2. <u>LKG</u>: The Date of Birth of the child should be between 01 March 2019 to 29 Feb 2020 (inclusive of both dates) (4 + years)

- 1. Limited seats are available, admission will be available on "FIRST COME FIRST SERVE BASIS"
- 2. Enrolment for Admission for the Academic Session commencing from March 2024 shall be done as per the schedule given below:
